

### **HKBAC** Update

#### Steady Increase in Runway and Parking Slots for Business Aviation Flights at VHHH/HKG

Following months of liaison with stakeholders, HKBAC's runway slots for general and business aviation operations between 1600-2059UTC have continued to increase. The additional slots are opened from 8 August 2018 until 31 March 2019.

The additional slots are opened to all types of aircraft, for both arrival and departure operations, without changes in application procedure. This latest addition came on top of an upward trend of runway slots since the beginning of the year. In Q2 2018, business and general flight movements have increased by close to 30% over the corresponding figure of last year. It is encouraging to see more day time and night time slots granted, which means that clients can fly with more flexibility and convenience.

#### Cross-boundary Movement of Physical Currency and Bearer Negotiable Instruments Ordinance

Bearer Negotiable Instruments Ordinance had come into effect on 16 July 2018 per the Customs & Excises Department of Hong Kong (Customs).

According to the ordinance, any person arriving in Hong

Kong via Hong Kong International Airport, who is in possession of currency and bearer negotiable instruments ("CBNIs") of a total value over HKD120,000 (or the equivalent in foreign currencies) is required to make a written declaration to a Customs officer. Meanwhile, any person who is about to leave Hong Kong is

also required to disclose, upon the request of a Customs

Officer, whether he/she is in possession of CBNIs of a total value over HKD120,000. If so, he/she should provide the required details in a written declaration.

requirements for the first time may make a payment of HKD2,000 to discharge his/her legal liability, provided that he/she has not previously been convicted of any money laundering or terrorist financing offences and whose CBNIs are not reasonably suspected to be crime proceeds or terrorist property. Other cases are subject to criminal proceedings, and the maximum penalty is a fine of HKD500,000 and imprisonment for two years.
